- Improve air quality by maintaining and expanding our green spaces
- Raise awareness of biodiversity at the University and encourage students and staff to engage in biodiversity activities
- Work in partnership with environmental groups and local authorities where appropriate, including support London Borough of Islington and London Borough of Tower Hamlets biodiversity guide and LBAP.
- Review and monitor bi-annually recorded habitats and species.
